

Not just “a place to die”, Hospice Services encompass a wide range of medical and social services to assist the terminal patient and their loved ones. Services include pain management, grief counseling and home health services such as bathing, laundry and companionship.

Hospice care is a package of services and programs provided to terminally-ill individuals and/or their caregivers and families. Hospice beneficiaries must be under the care of a physician. Hospice is a centrally-administered program of palliative care (i.e. services which do not cure illnesses, but produce the greatest degree of relief from the symptoms of a terminal illness) and supportive care. Services include physical, psychological, spiritual and sociological care, which is available 24 hours a day, 7 days a week. Hospice services include bereavement -- assistance to the family and caregivers after the death of the hospice patient.

Hospice services can be delivered in the home, in a licensed health care facility such as a nursing home, in a hospice residential facility, in an inpatient hospice facility, or through a hospice day care center. Usually, an interdisciplinary team consisting of a physician, a registered nurse, clergy/counselors, volunteers and other specialists work with the terminally-ill person and his/her family or caregivers.

Core services are physician and nursing care, pastoral counseling and social counseling. Each hospice patient receives a copy of the Hospice Patient’s Bill of Rights and Responsibilities. Some of the rights include being informed of the hospice program, services to be provided, options available and associated charges; participating in development of the care plan; the right to refuse services or withdraw from the program.

Hospices also offer respite services to allow family members to get away for a short period of time. While these services may be provided in a hospital or nursing facility, most are made available to the patient in their present home environment. Medicare and Medicaid will pay for Hospice Services. If the individual goes to an inpatient residential program, a nursing home or hospital-based hospice, they will be responsible for paying room and board charges.
